This is the last Will and Testament of me Miriam Brown of Aldbourne in the County of Wilts Spinster which I make and publish in manner following (that is to say) first I direct all my just debts funeral and testamentary expenses to be fully paid and satisfied by my executors hereinafter appointed then I give and bequeath unto my Nephews and Nieces Thomas, Sarah, John and Mary Ann sons and daughters of my brother Thomas Brown and to William, John, Susan and Elizabeth sons and daughters of my brother William Brown the sum of one hundred and fifty pounds each and I direct the same to be paid to them respectively as soon as conveniently may be after my decease and as to all the Rest Residue and Remainder of my personal estate and effects I Give and Bequeath unto my Nephews and Nieces William, Ann, Sarah, Mary, Martha, John, Stephen and Thomas sons and daughters of my late sister Mary Brown equally to be divided between them share and share alike to and for his her and their own use and benefit and lastly I do hereby nominate and appoint the last mentioned William Brown and John Brown joint Executors of this my Will hereby revoking all former and other wills by me at any time made and declaring this alone to be my last Will and Testament In Witness whereof I have hereunto subscribed my name and affixed my seal this twenty fifth day of September in the year of our Lord one thousand eight hundred and twenty eight _ *Miriam Brown*
