I Bathsheba Carr of Bradford in the County of Wilts Widow do hereby revoke and make void all former Wills by me made and Declare my last Will and Testament in manner following (that is to say) ffirst I give Ten Pounds each to my two Sons Thomas and James Carr at their ages of Twenty one Years and to my Son Henry Carr ten Pounds in hand and my Will and desire is that my Executor shall find and provide for his said two Brothers Thomas and James sufficient Apparel of all sorts until they have served their Apprenticeship or in default to pay each of them ffive Pounds a Yeare Item I give to my Son Joseph Carr fifty Pounds to place him apprentice and for Cloaths Item I give Devise and Bequeath unto my Son Samuell Carr his Heires and Assignes for ever the three Grounds called Upper Street Close Lower Street Close and the Oake Grounds in the Parish of Bradford aforesaid Item I give to my son Henry Carr the bedsteed and Appurtenances I usually lodge in and all the ffurnace and boylor I give my Weding Ring to Joseph with the Silver Spooone whereon is wrote

his own name I give to my Sons Thomas and James two Mourning Rings that was their Unkle's each one And to Henry one Gold Ring Item all the rest residue and remainder of my Lands Tenements Goods & Chattles whatsoever and wheresoever whereunto I am in any waies interested in or entitled unto I give Devise and bequeath the same unto my Son Samuell Carr his Heires and Assignes for ever And I do nominate and appoint my said Son Samuel Carr sole Executor of this my last Will And I do hereby Charge and make lyable all and every part of my Reall and Personall Estate before given to my Son Samuell Carr for payment of my just Debts and the Legacyes before given and I do Will the ten Pounds before given to my Son Henry Carr in hand at the end of one Yeare next after my death and not otherwise and I do desire Mr Richard Yerbury of London and Mr Thomas Penrey of Bath to be assistants to my Executor and family and to see this my Will performed In Witness whereof I have hereunto set my hand and Seale this Eighteenth day of December one Thousand Seven Hundred and Thirty Six \_ *Bathsheba Carr*
