In the Name of God Amen I Daniel Clutterbuck of Bradford in the County of Wilts Gentleman Do make and declare this my last Will and Testament as follows Whereas I and my Brother Lewis some time past at our Joint Expencc purchased of the Trustees of the late Lord Chedworth the Mannor of Southwick in the Parish of North Bradley in the County of Wilts and the Conveyance thereof was made to myself only Now I do hereby Give and Devise all my estate Right Title and Interest in the said Mannors and all Lands and Heredit thereto belonging I mean as well my own Moiety as the Moiety I hold in

Trust for my said Brother To hold to him my said Brother Lewis his Heirs and Assigns for ever Subject to the paying of two Annuities of Thirty Pounds each one to my Sister Elizabeth Gilling the other to my Sister Mary and during their respective Lives Clear of all Taxes whatsoever and at the four usual Quarterly Days of Payment in the Year Lady Day St John the Baptist St Michael the Archangel and St Thomas the Apostle the first payment of each Annuity to be made on such of the said Days as shall happen next after my death with all Powers and remedies for recovering the same as are usually given for recovering Rent Charges or Annuities by distress of Entry or otherwise and also Subject to the Payment of Eight Hundred Pounds to my Brother Thomas in Six Months after my Death without Interest Item I Give devise and bequeath to my Nephew Daniel Clutterbuck the Messuage or Tenement wherein I now dwell with the Garden and outhouses thereto belonging together with all my Plate China Linnen Pictures and Household Goods and ffurniture thereto belonging also my House adjoining in the possession of Mrs Warman and likewise my House called the Ship and the Garden I hold under Mrs Methuen with all Buildings thereon To hold to him my said Nephew his Heirs Executors and Admors for ever for all such Estates and Interests respectively have therein And Lastly I Give Devise and bequeath to my Brother Edmund Clutterbuck all and every other my Messuages Lands Tenements Rents and Hereditis whatsoever and all other my Real and Personal Estate whatsoever To hold to him his Heirs Executors and Admors for ever Subject to the paying of my Just Debts ffuneral Expences and to the paying two hundred Pounds to my Brother Thomas and Thirty Pounds a piece to Each of my said three Brothers Wives for Mourning and to ten pounds a piece to my two Servants Elizabeth Seley and John Pearce And I hereby revoke all former Wills and Testaments by me to made and declare this my last Will and Testament and do appoint my two Brothers Edmund and Lewis joint Executors thereof In Witness whereof I have hereunto set my hand and Seal this thirteenth day of April One thousand seven hundred and Sixty Nine *Dani*
