In the Name of God amen I Sarah Hatch widow Of The Parish of Bramshaw and County of Wilts Being Weake in Body but of Sound memory (Blessed be God) do This Twenty Fourth Day of July In the year of our Lord one Thousand Seven Hundred and Sixty Make and Publish This my last will and Testament in manner Following (That is to say) First my Desire is to be buried by my Late Husband at a Place Called Lyndhurst at the Discretion of my Executor Hereafter named Imprimise I give unto John Chandler of Amesbury and to my Sister Elizabeth the Now wife of John Chandler The sum of Twenty Shillings To be Equally Divided Between Them Also I give unto James Hatch and Anne Hatch Son and Daughter of James Hatch Deceased The sum of One Shilling Each Also I give unto my Sons In Law John Hatch and William Hatch And to my Daughters in Law Martha The wife of Edward Rickes and to Honor the wife of Henry Whithorn and Mary the wife of Richard New The sum of Five Shillings To Be Equally Divided Between Them also I give Unto my Brother in Law William Plasket The Sum of one Shilling All the Reast Resedue and Remainder of my Estate money Stock of Cattle Household goods and allo..... Thing Else whatsoever I shall Die Possessed off after my Decease I Give to ..... Henry Plasket James Plasket Sons of the said William Plasket William Baby John Baby Elizabeth Baby Anne the wife of James Andrews Eamy the wife of Richard Renalls John Brown And John Hinnin Equally To be Divided Between Them after all my Lawfull Debts be Dischard and Paid and my will is that all my Legacies be Paid at The Space of one whole year after my Decease and not before by my Executors hereafter Named And Too hereby Inpower The said John Hinning To Receive and Collect all monies that shall be due at my Decease and allso to sell And Dispose of my Household goods and or any thing els that Die possed of and The monies So to Dispose of According to my Will above written and I do Hereby Nominate and Appoint John Hinnin to be my whole and Sole Executor In witness whereof I have Hereunto set my Hand and Seal The Day an year First above written The mark of Sarah X Hatch
