“Also we present the highway between the house of John Gye (Think it is Eyre on reflection) and ... gate called Sippgate to be in disray and unrepayied and ought to be repayed by the inhabitants of Bromham .....that they wil and sufficiently pay the same between this and the 14<sup>th</sup> June next ....payne to ....to the said Lord of the Mannor.”

“Also we present John Hiscoke the son of Hennerly Hiscoke for being drunk on the fifth day of this instant month of April afore hth forfeited to the .. of the poore of Bromham aforesaid the somme of .b according to the statue in that .. made and provided? “

“Also we present William Bayly for that he hath not made his bonds between him and Walter Gaby according to the order of the ..”

Sworn in Daniel Baylie

Charged: Gabrielle Goldney the young, ....Robert Rawlins, ....

**28 March 1654**

Sworn in John Baylie

Charged: ...William Baylie, Thomas Baylie,.....Daniel Baylie,...

**28 Mar 1654**

Sworn in John knee

Charged: Wiliam Bayie,...

"Ordered that Alice Baylie widow shall sufficiently repayed her bonde next into a ground of Thoms Smart ....."
