Castle Eaton

1822

Petitions of Insolvent Debtors to be held at the General Quarter Sessions of the Peace to be held at New Sarum, by adjournment, in and for the county of Wilts, on Wednesday the sixth day of March next, at the hour of ten o'clock in the morning. Joseph Wilkins, late of Castle Eaton, in the county of Wilts, shopkeeper. **Salisbury and Winchester Journal, Monday, 11 February 1822**

1827

Committed to the House of Correction, Devizes: William Mavelin and James Hewer, both of Castle Eaton. For three months each for breaches of the game laws. **Salisbury and Winchester Journal, Monday, 29 January 1827**

1828

Wilts Sessions at Warminster. 3 months: James Legg for stealing a pig trough at Castle Eaton. **Bath Chronicle and Weekly Gazette, Thursday, 24 July 1828**

1829

Committed to the House of Correction, Devizes. John Legg for three months, for stealing a quantity of apples from an orchard, the property of Mr. William Smith of Castle Eaton. **Devizes and Wiltshire Gazette, Thursday, 24 September 1829**

1831

John Wilkins the younger has been committed to Fisherton Gaol, charged with having sent a letter to the farmers of Castle Eaton, threatening to destroy their property by fire, unless more wages were given to the labouring classes. **Bath Chronicle and Weekly Gazette, Thursday, 3 March 1831**

1834

Committed to the House of Correction, Devizes: Robert Newman; for three months, for leaving the service of John Archer, of castle Eaton. **Salisbury and Winchester Journal, Monday, 28 April 1834**

The perpetrator of the fire at Mr. Archer's at Castle Eaton, is not yet discovered, although £400 is offered. **Reading Mercury, Monday, 24 February 1834**

1837

Wilts Quarter Sessions James Hewer, alias Legg, for stealing two hurdles, at Castle Eaton (his second offence); Seven Years. **Salisbury and Winchester Journal, Monday, 16 January 1837**

1838

Committed to Marlborough Bridewell: Jeremiah Pope for six weeks, for leaving the service of George Moore Edwards at Castle Eaton. **Devizes and Wiltshire Gazette, Thursday, 2 August 1838**

1840

Committed to Marlborough Bridewell: John Green, 1 month, leaving service at Castle Eaton. **Salisbury and Winchester Journal, Monday, 20 April 1840**

Committed to Marlborough Bridewell: John Farmer, 2 months, breaking windows at Castle Eaton. **Salisbury and Winchester Journal, Monday, 25 May 1840**

1843

Committed to New Prison Devizes: James Cook 2 months and William Maggfig 1 month, vagrancy at Castle Eaton. **Salisbury and Winchester Journal, Saturday, 19 August 1843**

1848

Committed to the New Prison, Devizes. James Haines, two months, leaving his family chargeable at Castle Eaton. **Bath Chronicle and Weekly Gazette, Thursday, 26 October 1848**

1849

Committed for trial. John Bristow, charged with stealing 2 pounds weight of pork, the property of Jonah Newman at Castle Eaton. **Devizes and Wiltshire Gazette, Thursday, 1 February 1849**
