1775 Stolen

From Chute, near Ludgershall Wilts, the 20th Nov. a large black puppy dog of the mongrel kind, between three and four months old, one part of his head white and the other black, with a mouse-coloured spot above his right eye, part of one of his ears white, the top of his tail cut off, both fore legs white, the hind legs of a mouse colour, and white feet, and answers to the name of Lion.

And whereas there is great reason to suspect that Thomas Rawlins of Collingbourne stole him, as both were missed at the same time; whoever will discover the person who stole him, or give notice where he is, so that he may be had again, shall receive Half a Guinea reward. 1779 To be Sold

For the remainder of a term of 99 years, determinable on a labouring man's life, aged about forty. The Mortagee's Title for securing £60 and interest at five per cent, by assignment of a Leasehold Estate called Flinty House situate in the Forest of Chute near Clanville and about two miles from Weyhill and Appleshaw, Hants consisting of a small farmhouse, with a garden, orchard, barn, and backside, and about six acres of inclosed arable land, now lett to a substantial tenant.

1782 Committed to Gaol

On Thursday last John Freemantle was committed to the gaol here (*Winchester*), charged with breaking open, in company with one John Brown, the house of Wm.Smart, of Chute, in this county, and stealing divers sorts of apparel, 9s. in silver, &c.

1783 Robbery

Whereas the House of Thomas Cook, in the parish of Chute, in the county of Wilts, was broke open on Friday the 28th of February last, and several pieces of gauze, lawn, muslin, and ribbons, of all colours, taken away, and likewise several pair of men's stockings, women's printed linen and black silk handkerchiefs, and one man's neck handkerchief.

This is to desire, that if any person did, about that time, buy any thing of this kind, which they have reason to suspect were stolen, they will give notice thereof, by letter, to the printer of this paper, and if such information shall be sufficient to discover the offender, the person giving the information may depend on his name being kept a secret, if he desires it, and that a reward of Ten Guineas shall be paid him on the conviction of the offender, without his name being revealed, by me. Tho. Cook. N.B. Several pieces of ribbon, with the marks taken off, supposed to have been those that were stolen, were found, in searching a house in Upton.

1788 To be Sold by Auction by John Darling
