Redeemer Jesus Christ to have pardon of all my Sins and my body I commit to the Earth to be decently buryed and as to my Worldly Estate wherewith it hath pleased God to bless me I dispose thereof as followeth Vizt. Imprimis I appoint the sume of Twenty five pounds to be laid out in or around my ffuneral Item I give to my Kinswoman Mary Coventry Twenty five pounds Item I give to my Kinsman James Cox Twenty five pounds Item I give to my Kinswoman Elizabeth Sartain Thirty pounds Item I give to Susanna the daughter of the said Elizabeth Sartain Tenn pounds and the Bed I now Iye on with the Bedsted and all things thereto belonging Item I give to my Kinsman Joseph Cox the younger Twenty five pounds Item I give to my Kinsman Thomas Cox twenty five pounds Item I give to my Kinsman John Cox twenty five pounds Lastly all the rest and residue of my goods Chattells and Personall Estate not before hereby bequeathed I give and bequeath unto John Sartain of Hurping Cross in the Parish of Corsham aforesaid Baker the said Thomas Cox and John Cox and I do make the said Thomas Cox John Sartain and John Cox Joint Executors of this my Will revokeing all other Wills by me at any time heretofore made In Witness whereof I have hereunto sett my hand and Seale the Twentieth day of ffebruary Anno Dm 1725 William Hulbert
