This is the Last Will and Testament of me John Mogg of Diltons Marsh in the Parish of Westbury in the County of Wilts, Cordwainer.

I give and bequeath unto my son James Mogg all that part of my new built tenement or dwellinghouse situate and being at a place called Slobs Lane at Diltons Marsh aforesaid and now in the occupation of Sarah Hooper together with one half part of the ground in front of the said dwellinghouse and also down to the bottom of the orchard that farthest side from the lane with all that may be growing thereon at the time of my decease To Hold the same with the appurtenances unto my son James Mogg his heirs and assigns for ever.

Subject and I do hereby charge and make liable the same hereditaments and premises with the payment of the sum of twentyfive Pounds lawful money of Great Britain unto my daughter Elizabeth Mogg within six calendar months next after my decease.

I also give and devise unto my son Thomas Mogg all that other part of my said new built tenement or dwellinghouse in Slobs Lane aforesaid and which is now unoccupied together with the other half of the ground in front of the said dwellinghouse and also down to the bottom of the orchard on the side against the lane with all that may be growing thereon at the time of my decease. To Hold the same with the appurtenances unto my said son Thomas Mogg and his assigns for and during the term of his natural life.

Subject and I do hereby charge and make liable the same with the payment of the sum of twenty pounds of lawful money of Great Britain unto my daughter Jane King

And also with the further sum of five pounds of like lawful money unto my said daughter Elizabeth Mogg which said sums of twenty and five pounds I will and direct shall be paid by the said Thomas Mogg within six calendar months next after my decease. And from and immediately after the decease of my said son Thomas Mogg I give and devise the last mentioned hereditaments and premises unto my said son James Mogg, my said daughter Elizabeth Mogg, and my said daughter Jane King, their heirs and assigns for ever equally to be divided between them share and share alike as tenants in common and not as joint tenants.

It is my Will and desire that in case any dispute arise as to the division of the ground or any other part of the premises before devised the same shall be settled and decided by my Executors hereinafter named whose determination shall he final and conclusive.

I Give Devise and Bequeath all that my tenement or Dwellinghouse garden and premises now in my own occupation together with whatever may be growing thereon at the time of my decease unto my said son Thomas Mogg and my said daughter Elizabeth Mogg To Hold the same with the appurtenances unto my said son Thomas Mogg, and my said daughter Elizabeth Mogg their Heirs Executors Administrators and Assigns for all my Estate and Interest therein equally to be divided between them share and share alike as Tenants in Common and not as joint Tenants.

All and Singular my household goods and furniture and also all other my personal estate and effects whatever and whosesoever subject to the payment of all my just debts funeral and testamentary expenses, I Give and Bequeath unto and equally between my said son Thomas Mogg, and my said daughter Elizabeth Mogg their Executors and Administrators to and for their own absolute use and benefit

And I hereby nominate constitute and appoint my friends The Reverend Thomas Gough of Westbury Leigh in the Parish of Westbury aforesaid Baptist Minister and Samuel Scott of Diltons Marsh aforesaid Carpenter, joint Executors of this my last Will and Testament hereby revoking, all former wills made by me at any time made. In Witness whereof I the said John Mogg have to this my last Will and Testament contained in two sheets of paper to the first sheet thereof set my hand and to this second and last sheet my hand and seal this Third Day of September in the year of our Lord One Thousand eight hundred and thirty Five.
