CAPTAIN WYNDHAM

DEATH OF CAPTAIN WYNDHAM.- Many of our sporting and other readers will, no doubt, regret to hear that the much-esteemed Master of the South Wilts Hounds is no more. For some few weeks Captain Wyndham's health had been unsatisfactory, and he was unable to pursue his favourite recreation with his accustomed zeal. His friends, however, could not induce him to give it up, and as late Wednesday week he appeared at the cover side. On Thursday he complained of a difficulty in breathing, which increased on Friday and Saturday. On the latter day he seemed to feel that his end was approaching, and at six o'clock in the evening he left his bed for an arm chair, when he immediately fell back and expired. Every remedy to restore life was used, but with no avail. At Dinton, where he has resided for about two years, his death has caused a gloom throughout the entire parish and neighbourhood. As a sportsman, considering his age, he was scarcely equaled, and as a true and faithful friend he will be unfeignedly and sincerely regretted. The poor have lost their best friend; one of his last acts will be long remembered by them, when he distributed a liberal supply of mutton at Dinton on Christmas Day.
