This is the last Will and Testament of me Henry Hacker of the Parish of Fonthill Gifford in the County of Wilts Carpenter firstly I direct that all my just debts and funeral and testamentary expences are paid and satisfied by my Executor hereinafter named as soon as conveniently may be after my decease and Secondly I give devise and bequeath to my natural Son William Day of Hindon in the said County now in the employ of Joseph Frowde Spencer Esquire the sum of five pounds and all my wearing apparel excepting my linen I give and bequeath to my nephew William Mould of the Parish

of ffonthill Gifford all my body linen And as to all the Rest Residue and Remainder of my Estate and Effects whatsoever and wheresoever both real and personal whether in possession reversion remainder or expectancy I give devise and bequeath the same unto the before mentioned William Day his executors and administrators upon trust to permit and suffer my dear Wife to have the use and enjoyment of all such parts thereof as shall not yield income and to invest the residue of such my estate as shall not have been applied in payment of my debts and funeral and testamentary expences and legacies in some one of the Government stocks or funds of Great Britain not being terminable annuities and to pay the dividends and produce thereof and also the interest dividends or annual produce of all such other parts of my said estate as shall yield income unto my dear Wife during the term of her natural life and should the said interest and annual income prove inadequate to her support my said executor shall advance her a sufficient sum of the principal money from time to time to make up the deficiency and after her decease I give devise and bequeath unto John Mould the son of my nephew the aforesaid William Mould on his attaining the age of twenty one years one third part of such monies which shall have been invested in manner as aforesaid and not expended in support of my Wife previous to her decease and in case of his decease unto the next surviving brother on his attaining the like age And as to all the residue of my effects The two remaining third parts or shares of the money invested my household goods and all other undescribed property of every description remaining after the decease of my said Wife and not otherwise I give and bequeath unto the aforesaid William Day his executors and administrators for his own use and benefit absolutely And I nominate constitute and appoint the before named William Day to be the sole Executor of this my Will and hereby revoking all former or other Wills and Testaments by me at any time heretofore made I declare this to be my last Will and Testament In Witness I the said Henry Hacker have to this my last Will and Testament set my hand this eleventh day of May in the Year of our Lord one thousand eight hundred and forty eight the Mark of Henry Hacker
