This is the last Will and Testament of me Elizabeth Edwards of ffroxfield in the County of Wilts Widow ffirst I will and desire that I may be decently interred in the Vault in the Chancel of the Parish Church of Preshute in the County of Wilts wherein the remains of my late husband are deposited I will and desire that all my just debts funeral and testamentary expences may be fully paid and satisfied I give and bequeath unto Mrs Mary Ann Edwards Widow of the Reverend William Edwards of Charlton in the County of Somerset Nephew of my late Husband the legacy or sum of fifty pounds sterling I give to my Cousin Elizabeth Sheppard of No 3 East Surry Place Waterloo Street Camberwell Green London the sum of nineteen pounds and nineteen shillings I give to Miss Elizabeth Heighway of Marlborough Wilts Daughter of the late Reverend Richard Heighway the sum of nineteen pounds and nineteen shillings I give to Mrs Mary of ffroxfield Cottage Wilts Widow the sum of nineteen pounds and nineteen shillings I give to Miss Mary Ann Brind of Liddington in the County of Wilts Spinster the sum of nineteen pounds and nineteen shillings I give to Mr ffrancis Hewer late of Wanborough Wilts but now of Southdown Cottage Ealing near Southampton all my plate And to Miss Mary Ann Hewer the sum of nineteen pounds and nineteen shillings likewise I give to Mrs Elizabeth Baverstock the Wife of Mr Charles Baverstock of Archer ffarm in the Parish of Ramsbury Wilts the sum of nineteen pounds and nineteen shillings All the Rest Residue and Remainder of my Real and Personal Property whatsoever and wheresoever and of what nature or quality soever not hereinbefore by me given and dispose of I give devise and bequeath the same and every part thereof unto Mrs Margaret fford of Little Hinton in the County of Wilts Widow To hold to her executors and administrators absolutely And I hereby appoint the said ffrancis Hewer Elizabeth Baverstock and Mary Ann Brind joint Executor and Executrixes of this my said Will And I hereby revoke and make void all former and other Wills by me at any time heretofore made and I declare this my last Will and Testament In witness whereof I have hereunto set my hand and seal this twenty first day of December in the year of our Lord one thousand eight hundred and fifty *Elizabeth Edwards*
