In the Name of God Amen I David Brock Senr of the Parish of Imber in the County of Wilts being of perfect Mind & Memory tho' weak of Body make this my last Will & Testament Item I give to Solomon Monday & Ann Monday his Wife my

Niece all my Household Goods namely a Copper Furnace 2 large Pewter Dishes 6 Pewter Plates 2 Pewter Dishes 2 Coffers 2 Feather Flock Beds (being mixed) 1 Bedstead 1 small square Table Board 1 large Table 1 Great Chair 1 small round Table 1 Silt 1 Quarter Barrel & 1 Three Pail Barrel 1 Small Box 1 Skillet 1 Pint and half Copper 10 Delf Plates 2 Glass 2 Pints 1 Salt Celler 1 Chest 1 long stool 1 short stool 1 Iron Pot & Pair Hangells 1 Pair Pothooks 2 Chairs 1 Fire Pan Tongs & Baker 2 Crutches 2 Boxes (small) 2 White Plates 11 Dishes Different Sorts 1 Pail 1 Scalebeam 2 Muggs 1 Washing Pan 1 Hande Brush 2 large Partingale Platters 1 large Pudding Pan 1 close Basket 1 Child's Chair 1 Saw 1 Hatchet 1 Hook 1 Frying Pan Also to my Son David Brock I give her of those four Gold Rings (namely 2 of them that is half the Value of all) that Mr Tinker now have of mine and the Money that Mr Tinker now have of mine Also the Money that Mr Everett of Heytesbury has of mine wch is now 30£ wch he pays me Interest for at the rate of 3 P Cent P Annum this I freely give to him (my Son William) if I leave it all behind me if not what I do leave I bequeath to him that is, all the Money that I leave behind me I give my Son William to be by him freely enjoyed & possessed without Molestation but in Case he should not survive me I give the same to his Child or Children if any to be equally Divided between them Also my two Tenements that I hold under John Wadman Esqr for the Lifetime of my two Sons & myself I freely give to my Son William and his Heirs & Heiress to be freely enjoyed by them only if enjoyed by his Child or Children my Will is that they shall equally share alike in the said Tenement Also I appoint Thos Wastfield Junr of Imber aforesaid my Executor requesting him to take it upon him to see that my Will is faithfully discharged & to order the same as he shall see prudent & his Expences to be defrayed out of the Money I shall have behind me whether in Mr Everett's W Tinker's or any other Person Hands this I declare to be my last Will & Testament & no other & I do hereby disannul & make void all former Wills Bequests & Legacies by me before named & do ratify this to be my last Will & Testament & no other Whereof I set my Hand & Seal this twenty fourth day of April one thousand seven hundred & eighty three The Mark of X David Brock Signed sealed published & declared to be the last Will & Testament of David Brock by him in the presence of us *Ruth Pearce* The Mark X of Levi Mabbet
