## Knook

At an Ordination held by the Lord Bishop of Salisbury in the Cathedral Church of Sarum, on Sunday the 22<sup>nd</sup> of May instant (being Trinity Sunday), the following gentlemen were admitted into holy orders

#### **DEACONS**

Alfred Samuel Littlewood, B.A., of Trinity College, Ox., licensed to the curacy of Heytesbury cum Knook.

On the 11<sup>th</sup> inst., the Rev. Edward Brice, B.A., was licensed as Assistant-Curate in the Churches of Heytesbury and Knook, and Chapel of Tytherington, Wilts.

On the 11<sup>th</sup> instant, was instituted by the Right Rev. the Lord Bishop of Salisbury, ....... the Rev. Stewart Lynch, clerk, B.A., to the Cuarcy of Heytesbury and Knook, Wilts.

On the 23<sup>rd</sup> inst. the Right Reverend the Lord Bishop of Salisbury licensed....... the Rev. Richard Gawler Mead, Clerk, M.A., to the Curacy of Heytesbury-cum-Knook and Tytherington, Wilts.

Died – The Rev. Preb. John Knight, vicar of Heytesbury and Knook, died at his residence, at the advanced age of 87, on Monday evening. The late vicar first came to Heytesbury as vicar in the year 1836, and since his incumbency has restored both his churches.

Died – On the 17<sup>th</sup> Sept., at Heytesbury, Wilts, the Rev. John Knight, M.A., 47 years Vicar of Heytesbury-cum-Knook and Prebendary of Tytherington, in his 87<sup>th</sup> year.

The Rev. W. J. Swayne, vicar of Chitterne, Wilts has been presented by the Lord Bishop of Salisbury to the rectory of Heytesbury with Knook, void by the recent death of Prebendary Knight. ... The new rector of Heytesbury, has also been appointed to the vacant mastership of the Hungerford Hospital.

The Bishop of Salisbury has appointed the Rev. A. D. Clutsom, M.A., vicar of Heytesbury with Knook and Tytherington, to be rural dean of the Heytesbury portion of the Deanery of Wylye, in succession to Canon Jacob, retired.
