CONFIRMATION OF BYE-LAWS. CEMETERY.

NOTICE IS HEREBY GIVEN that the Urban District Council of Melksham intend, after the expiry of the period mentioned below, to apply to the Minister of Health for confirmation of Bye-laws made by the Council under Section 2 of the Public Health (Interments) Act, 1879, and Section 198 of the Public Health Act, 1936, with respect to the charges for the use of the Cemetery provided by them in the Urban District of Melksham.

Copies of the said Bye-laws will be kept at the Office of the Council at the Town Hall, Melksham, and will be open to public inspection, without payment, on any week-day during the usual office hours for one calendar month from and after the date of the publication of this notice. Copies of Bye-laws or any part thereof will be supplied at a fee of 6d. for each 100 words. Any objection to be made by letter addressed to the Secretary, Ministry of Health, London, S.W.1, before the Bye-laws are confirmed.
