## 1839

April 9, at Winchester, aged 64, the Rev Thomas Watkins, senior Minor Canon of Winchester cathedral, vicar of Minety, and last surviving brother of Mrs. Lander, Wellington Parade, Gloucester. **Devizes and Wiltshire Gazette, 18 April 1839** 

On the 9th inst., at Winchester, in the 64th year of his age, the Rev. Thomas Watkins, M.A. vicar of Collingbourne Kingstone, and of Minety, Wilts, Chaplain of Winchester College, and Precentor of the Cathedral, in which he held the office of minor Canon for 37 years. The diligence and ability of Mr. Watkins in leading and directing the choral service, and his attention to the charitable institutions of the city, and the wants of the poorer inhabitants, will long be remembered. Mr. W. was a native of this city, and for some years, a member of this College and Cathedral, till his appointment to Winchester in 1803. Hereford Times, Saturday, 20 April 1839
