In the meadows owned by Mr Stanley Westlake, one of the churchwardens, there grows a rare wild flower known as the "fritellaria." This spring he made a small charge to the visitors who come from a wide area to gather these flowers.

Mr R Hitchings was re-elected chairman and Mr S H Westlake vice-chairman at Oaksey Parish Council meeting.

Mrs E Hislop was selected for nomination as manager of the Church of England school by the county education authority and Mr Hutchings was elected as manager of the school by the Council.

A precept for £5 was endorsed to be served on the Rural Council.

The clerk, Mr J S Buckland, was instructed to draw the attention of the surveyor of the Rural Council to several road questions.

Coronation Festivities

After the service in Oaksey Church, a cricket match, married versus single, with Mr M Todd, of The Dean, as captain of one side, was played. There was also a dinner and meat tea for the women and children. Over £33 was collected for the festivities generally, and £7 for the sports.

Parish Council

Mr Richard Hitchings presided at Oaksey Parish Council meeting.

The clerk was instructed to write to the postmaster at Swindon asking for the park corner letter-box to be cleared on Sunday evenings, and also to call the road surveyor's attention to the condition of the road opposite the blacksmith's shop.

It was stated that ratepayers objected to having to go to Malmesbury to pay their rates, and they asked if a clerk could attend on a specific day and collect the money.

Malmesbury Emergency Instructions (part of)

The report of the Oaksey Water Committee stated that there was a plentiful supply of water in the local well, but as there was a weak supply in some parts of the village, the building surveyor had been asked to make an examination of the mains.

It was decided that Mr T Pendlebury, the Oaksey waterworks manager, should given notice to terminate his engagement on June 30 and that applications should be invited for the position. The employment is part time, and the salary is £30 annually.

House Shortage at Oaksey

The Rev T J V Williams presided at a parish meeting held at Oaksey.

After some discussion, the following resolution was carried unanimously:

"That this representative parish meeting strongly urges the Rural Council to provide more houses in Oaksey. There are three condemned and 26 to be reconditioned in the village, and conditions under which theses people live should not be tolerated any longer. There are four applicants for bungalows and 21 for council houses."

Sir – We understand that the Crudwell, Minety and Oaksey gave the children allotted them a poor reception. Oaksey parishioners would like to say the fault does not lie with them. Without exception the children and teachers included were sent into cottages. We understand that a farmhouse two minutes walk from the school had made arrangements to receive the children but was refused any. But three days later two teachers found good accommodation at the same farm. There are at least half a dozen houses in the parish. Why are none installed in any of these? Without exception the children have good homes and are very happy. May no reflection be cast on the cottagers.

They were Mr J Cuff, the motor-cyclist, and Mr J M Ettles, both of Oaksey, and they were taken by ambulance to Cirencester Memorial Hospital.

Former Tenant Stays

The decision of the Wilts Agricultural Committee that a former tenant should be allowed to remain in possession though his landlord wished to have the farm for his ex-Service son, was upheld at a Land Tribunal conducted by Sir Leonard Costello (chairman of the Land Tribunals, South-West area) at Cirencester yesterday.

The landlord, Mr Walter Noah Ody, of "The Chestnuts," Kington Langley, near Chippenham, had appealed against the decision which allowed Mr Osborne-Smith to remain the tenant of Clattinger Farm, Oaksey, near Malmesbury.
