Yeoman and five pounds to my Cousin Elizabeth Wife of John Pain of Oaksey aforesaid Labourer which said legacies was given and bequeathed to them in and by the last Will and Testament of my late Husband Benjamin Maysey of Oaksey aforesaid Yeoman deceased also further give and bequeath unto my said Nephew Thomas Sparrow the sum of five pounds I also further give and bequeath unto my said Sister in Law Sarah Wife of the said Robert Beames the sum of five pounds I also further give and begueath unto my said Cousin Elizabeth Wife of the said John Pain the sum of five pounds I also give and begueath unto the several Sons and Daughters of my Brother in Law William Alexander late of Hilmarton in this County Yeoman deceased the sum of thirty pounds to be equally divided amongst them share and share alike and in case any or either of them shall happen to die before myself or within one year next after my decease Then my Will is that the share of him her or them so dying shall go to and be paid amongst the Survivors or Survivor of them share and share alike I also give and bequeath unto the several Sons and Daughters of my late Brother in Law Samuel Stiles late of Hilmarton aforesaid Yeoman deceased the sum of thirty pounds to be equally divided amongst them share and share alike and in case any or either of them shall happen to die before myself or within one year next after my decease Then my Will is that the share of him her or them so dying shall go to and be paid amongst the Survivors or Survivor of them share and share alike I also give and bequeath unto the several Sons and Daughters of my late Brother William Rodgers late of Liddiard Treygoese in the said County Yeoman deceased the sum of forty pounds to be equally divided amongst them share and share alike and in case any or either of them shall happen to die before myself or within one year next after my decease Then my Will is that the share of him her or them so dying shall go to and be paid amongst the Survivors or Survivor of them share and share alike I also give unto Elizabeth Rodgers Widow and Relict of the said William Rodgers the sum of ten pounds I also give unto my Nephew Thomas Godwin Son of William Godwin of Oaksey aforesaid Yeoman the sum of twenty pounds I also forgive my Cousin William Weeks of Oaksey aforesaid Yeoman all money due and owing to me from him upon Promissory Note and also all other Monies due to me from him for Goods sold and delivered and Money lent at several times And my Will is that he shall never be impleaded or sued for the same I also give unto my Niece Eleanor the Daughter of the said William Weeks the sum of five pounds I also give unto my Niece Ann the Daughter of the said William Weeks the sum of five pounds I also give unto my Cousin Mary White Daughter of John White late of Eastcourt in the Parish of Crudwell in the said County Yeoman deceased the sum of five pounds I also give unto my Nephew Henry Bristow of Swindon in the said County Blacksmith the sum of five pounds I also give unto my Nephew William Bristow of the same place Blacksmith the sum of five pounds And I do will and order that all and singular the Legacies aforesaid shall be paid in lawful British Money to the respective Legatees by my Executor hereinafter named within one Year next after my decease And I so herby nominate constitute and appoint my Nephew William Godwin the younger of Oaksey aforesaid Yeoman sole Executor of this my last Will and Testament to whom after my Debts Legacies abovesaid and Funeral Expenses are paid I give and bequeath all the residue and remainder of my Goods Chattels Money Securities for money and Personal Estate of what nature sort kind or denomination soever And Lastly I do hereby revoke and make void all former and other Wills by me at any time heretofore made and confirm this to be my last Will and Testament contained in two sheets of paper set my hand seal to each sheet thereof this eleventh day of September in the year of our Lord one thousand seven hundred and seventy nine
