In the Name of God Amen I Thomas Coxe of Oaksey in the County of Wilts Yeoman being of perfect memory blessed be my Maker for the same minding my Latter End and the uncertainty of the time thereof I do make this my Last Will and Testament in manner following Imprimus I give unto Judith my Wife five shillings in money to be paid to her by my Executors in one month after my decease. Item I give unto my Cozen Edward Coxe of Tarleton in the County of Gloucester Yeoman the sum of Ten Pounds to be paid in one year after my decease and unto William Coxe Thomas Coxe and Richard Coxe his Brothers and Richard Ball Son of Richard Ball of Kemble five shillings a piece to be paid within one year after my decease, and I give unto Hannah Coxe and Martha Coxe Sisters of my Cozen Edward Coxe of Rodmarton and to Thomas Mason of Bisley in the said County of Glouc^r and his Sister Sarah five shillings a piece to be paid in like manner also I give to Robert Ford Sonne of Humphry Ford and to Mary and Jane his Sisters five shillings a piece to be paid within one year after my decease. Item I give unto my Cozen William Phillimore of Lower Cam in the said County of Glouc^r Yeoman the sum of Ten Pounds and to all his children five shillings a piece. To his Brother Samuel Phillimore the summe of five pounds, and to Christian Anne and Jane their Sisters five shillings a piece to be also paid within one year after my decease. Item I give and bequeath all that my Leasehold Messuage Tenement and Lands with the appurtenances in Shipton Moyne in the said County of Glouc^r which I hold of the demise and Grant of Walter Estcourt Esquire and the Lease thereof unto William Phillimore the younger Son of the said William Phillimore of Lower Cam and unto Thomas Coxe Sonne of Giles Coxe of Cirencester in the same County and to their assigns to be equally divided between them for and during all the items and Estate as shall be to come therein at my decease. Item All the residue of my Moneys Goods Chattells and personal Estate my debts and Funeral being discharged I give unto my said Cozens Edward Coxe of Rodmarton and William Phillimore of Lower Cam to be equally divided between them who also I make joynt Executors of this my Last Will and Testament Revoking hereby all former Wills In Witness whereof I have hereunto Sett my hand and Seale the Seventh day of April in the year of our Lord One Thousand Seven Hundred and Eleven
