In the Name of God Amen I John Canning the Elder of Ogborne Saint George in the County of Wilts Do make publish and declare this to be my last Will and Testament in manner following that is to say first my Will and desire is that all my just Debts funeral and testamentary charges and expences be duly paid and satisfied I give and bequeath to my dear Wife Rebecca Canning the Sum of fifty pounds to be paid to her at the expiration of one month next after my decease also I give and bequeath unto my five Sons Robert Richard John Thomas and William The Sum of Two Thousand and three hundred pounds Upon trust that they my said Trustees and the Survivor of them and the Executors and admors of such survivor shall and do immediately after my decease place out and invest the same in the Public Stocks or funds upon good Real or Government Security at Interest in their or his own names or names and do and shall from time to time call in and reinvest the same as they or he shall think proper and upon this further Trust to pay apply and dispose of all the Interest Dividends and annual proceeds thereon when and as the same shall become payable unto my said Wife or otherwise permit suffer and authorize her to receive and take the same from time to time during her natural life and for her own use and benefit and from and after her decease Then I direct that the said Sum of Two Thousand and three hundred pounds shall go to and be equally divided amongst my said Sons share and share alike to and for their own absolute use benefit and disposal and in case of the decease of any or either of my said Sons in my lifetime without leaving lawful Issue him surviving then the share or shares of him or them so dying of and in the said Sum of Two Thousand and three hundred pounds shall go to and be divided amongst the survivors of them in equal portions if more than one and if there shall be only one Then the same shall go to such only one also I give and bequeath unto my Daughters Rebecca the Wife of Mr John Tanner Elizabeth the Wife of Mr William Large and Mary the Wife of Mr Bryan Bewley the Sum of Seven hundred pounds a piece to be paid to them at the expiration of six months next after my decease also I direct that my said Wife shall have the use and enjoyment of all my household Goods and furniture beds bedding Plate Linen and China for and during the term of her natural life and after her decease I give and bequeath the same and every part thereof unto and to be equally divided amongst my said Sons share and share alike and all the Rest Residue and Remainder of my Monies and securities for money personal Estate and Effects whatsoever and wheresoever I give and bequeath unto my said five Sons to be divided between them in equal parts and proportions share and share alike at the expiration of twelve months next after my decease and I do hereby nominate and appoint my said five Sons Robert Richard John Thomas and William joint Executors of this my Will and do revoke and make void all former and other Wills by me heretofore made In Witness whereof I the said John Canning the Elder have to this sheet of this my Will contained in two sheets of paper set my hand and to this second sheet thereof my hand and seal the 9<sup>th</sup> day of September in the year of our Lord 1820 *John Canning*
