chattels whatsoever to be parted equally betwixt my daughters Betsey Davedore Still & Harriet Sophia Prewett or sold at their own discretion and if any money remains after the stock at my decease is sold and the £400 and the bond on the Law Life Insurance & it shall be equally divided betwixt my beloved Wife and my daughters Betsey Davedore Still & Harriet Sophia Prewett except Fifty Pounds which I give out of the same to my grandson William Thomas Gibbons Prewett to be put out to interest to apprentice him if he should live and if he dies before the age to be apprenticed the money to be divided betwixt my daughters as above named and I hereby constitute and appoint my beloved wife to be Sole Executrix to this my last Will & Testament hereby revoking disallowing & disannulling all former Wills made by me at any time whatsoever In witness whereof I have set my hand this 10th day of April One thousand eight hundred and forty eight _ Thomas Nichs Prewett Witness to the Signature Thomas Pragnell _ Charles Adams
