In the Name of God Amen I Ambrose Thomson of Ramsbury in the County of Wilts being sick in body but of sound and perfect mind and memory (thanks be to God for the same) Doe make and declare this my last Will and Testament in manner and forme following ffirst and principally I commend my soul to God who gave it And my Body I committ to the Earth to be decently buried therein at the discretion of my Executor herein after named And as touching such worldly Estate as it hath pleased God to bless me withall I dispose thereof in manner following (that is to say) Imprimis I give devise and bequeath all my Leasehold Estate situate and being in Newington unto my loveing Grandson Phillip Hill of Ramsbury in the County of Wilts Innholder for the remainder of the Term and Estate I have therein Item I give devise and bequeath unto my said Grandson Phillip Hill All that my ffreehold Messuage or Tenement with the Backside Orchard and Garden thereunto belonging situate and being in Ramsbury aforesaid To Hold to him the said Phillip Hill his Heirs and Assignes for ever Item I give and bequeath unto my son Ambrose Thomson and to my Grandchildren Ambrose Thomson and Esther Thomson one shilling apeece Item I give and bequeath unto my Grandson Alexander Thomson the sume of Ten Pounds to be paid him by my Executor within one year next after my decease Item all the Rest and Residue of my Goods and Chattells Reall and Personall and all other my Estate and Substance whatsoever and wheresoever I give

devise and bequeath unto my said Grandson Phillip Hill whom I constitute appoint and make my sole Executor of this my last Will and Testament hereby revokeing all former Wills by me made In Witness whereof I the said Ambrose Thomson have to this my last Will and Testament set my hand seale this Sixteenth day of July in the Seventh Year of the Raigne of our Sovereigne Lady Ann by the Grace of God of Great Brittain ffrence and Ireland Queen Defender of the ffaith Anno Domini 1708 Ambros Thomson his marke
