In the name of God Amen I Edward Appleford of Axford in the parish of Ramsbury in the County of Wiltshire Yeoman being sick and weake in body but of sound minde and memory doe make this my last Will and Testament Revoking all Wills by me formerly made And as touching such worldly estate as God hath beene pleased to blesse me withall I doe hereby give devise and bequeath the same in manner following (That is to say) Imprimis I doe give devise and bequeath all my Free land lying and being in Axford aforesaid being a Messuage or Tenement and parte of a Yardland commonly called and knowne by the name of Peerses Togeather with all its rights membered hereditaments and appurtenances thereunto belonging. And all other my Lands Tenements and hereditaments whatsoever in the said County of Wiltshire

unto my sonne Daniell Appleford To hold the same unto the said Daniell and his assignes for and during the terme of his naturall life And after his decease to the heires Males of his body lawfully begotten and to be begotten And for want of such issue to my Grandchilde Edward Appleford and his assignes for and during the terme of his natural life And after his decease to the heires Males of his body lawfully begotten and to be begotten And for want of such issue to my Grandchilde Thomas Appleford and to his heires forever Item I do give and bequeath unto my sonne Thomas Appleford six and Twenty pounds which is now due and owing unto me from the Said Thomas upon two Bonds Item I doe give and bequeath unto my loving wife Mary Appleford the [Executors?] yeare of one living in Axford aforesaid called by the name of Pitt houses or Bayman's Yardlands Item I do give and bequeath unto my daughter Mary Appleford the sume of One Hundred pounds of lawfull money of England to be paid unto her within Two Yeares next after my decease Item I do give and bequeath unto my daughter Francis now the wife of John Say the sume of Twenty pounds of lawfull money of England to be paid unto her within one yeare next after my decease Item I do give and bequeath unto my daughter Elizabeth now the wife of William Burchall Ten shillings to be paid her within one yeare next after my decease Item I do give and bequeath unto my said Two Grandchildren Edward and Thomas Five pounds a piece to be paid unto them at their respective ages of One and Twenty yeares But my will and meaning is that if either of my said Two Grandchildren Edward and Thomas shall happen to die before he attains to his full age of One and Twenty yeares that then the aforesaid Legacies so given shall come and remayne to the Survivor thereof Item I do give and bequeath unto my sonne Daniell Appleford the Maltmill Yoating Stone the Furnace and the Press now standing in his Chamber And all the rest of my houshold Goods I doe give and bequeath unto the said Mary my wife and to the said Daniell my sonne to be equally divided betweene them And all the rest of my goods Chattels and Creditts whatsoever and wheresoever not hereby given and bequeathed (my debts Legacies and Funerall expences paid and discharged) I doe give and bequeath the same unto my said Sonne Daniell Appleford whome I do hereby make the Sole Executor of this my last Will and Testament In Witness whereof I have to this my last Will sett my hande and seale the Sixth day of July in the Fifth yeare of the Raigne of our soveraigne Lord and Lady King William and Queene Mary Anno Domini 1693
