In the Name of God Amen I James Shrimpton of the Parish of St Thomas in the City of New Sarum in the County of Wilts Gentleman being of sound and disposing mind do on this first day of March in the year of our Lord one thousand eight hundred and thirty four make publish and declare this my last Will and Testament in manner and form following I give to Mr John Humby of the City of New Sarum (Pastry Cook) upon trusts all my Goods & Chattels Clothes China Plate money and securities for money namely 50 pounds secured in the 3 Pr Cent Consols bearing date 21<sup>st</sup> day July 1825 Also 160 pounds in the 3 Pr Cent Consols bearing date 5<sup>th</sup> day of March 1833 Also 231 – 8 – 8 deposited in the savings Bank at Greenwich Lewisham & Lee belonging to me with all the interest or dividends that may be due on the same at the time of my decease and all other my property of what kind soever or wheresoever and after paying my debts and funeral testamentary and other expences attending the execution of this my Will that then Upon Trust the said John Humby whom

I appoint as my sole Executor of this my Will shall as soon after my disease as possible proceed to the distribution of the whole of my remaining property in the following manner I give to my Niece Emily Shrimpton the Sum of ten pounds of lawful money of great Britain also the whole of my China and trinkets I also give to Mr John Humby as my Executor the Sum of five pounds of lawful money of great Britain as a small remuneration for his trouble And all the remaining part of my Property I give in equal shares to my three Brothers one third part to Charles Shrimpton of Winchester in the County of Hants Labourer one third part to William Shrimpton of Ashmonsworth in the County of Hants Labourer and one third part to John Shrimpton of Woodhouse in the County of Hants Labourer but it is my particular wish and desire that each of my Brothers shall pay out of such legacy one shilling weekly to my ffather William Shrimpton during his natural life but should either of my brothers die before the execution of this my Will I desire that his share shall be given to the children of such deceased brother in equal shares share and share alike In witness whereof I have hereunto set my hand and Seal this first day of March in the year of our Lord one thousand eight hundred and thirty four *James Shrimpton*
