



PARISH CHURCH, TROWBRIDGE, WILTS.

The above Church has been for sometime in such a dilapidated and dangerous state as to be unsafe for public worship, and on careful examination has been found necessary to be taken down excepting the Tower, Steeple, and a portion of the outside walls. Plans and estimates for rebuilding have been received and approved. The sum required to Rebuild and Restore this Edifice in accordance with the portion still remaining is £6,000, of this sum £1,000 has been granted by a Church-rate, the remaining sum of £5,000 must be raised by voluntary contributions. – The population for which this church is rebuilding is upwards of 9,000, chiefly manufacturing poor, and number of sittings will be 1000

It will be seen by the amount already raised in the Parish that the parishioners have done what they could, thus testifying their great anxiety to preserve and restore this beautiful Gothic Edifice, which has not only been the ornament of the town, but of the County.

This appeal is now made to a benevolent public in the earnest hope, that through their kindness and generosity, this good work may be accomplished, affording the accommodation so much needed; at the same time maintaining the original beauty and character of the building.
