I Martha Millard of Warminster in the County of Wilts Widow Do hereby revoke and make void all and every Will and Wills Testament and Testaments by me at any time heretofore made and do declare this only to be my last Will and Testament which followeth that is to say first I will that my Debts and funeral Expences be paid and satisfied Also I give and bequeath to Henry and Elizabeth the two Children of my Kinsman William Painter the Sum of ten Pounds a Piece to be paid to them with the Interest thereof at their respective Ages of Twenty one Years And if either of them dies before the said Age the whole to go to and be to the Survivor of them I give to my Kinswoman Martha Painter Daughter of my Brother in Law John Painter the Sum of twenty Pounds and to her Sister Elizabeth Painter the Sum of fifteen Pounds Also I give and bequeath to my Kinsman Stephen Long of Kingston Deverill the Sum of twenty Pounds and to his Sister Anne Long the Sum of seven Pounds All which said Legacys I will shall become due and Payable at the end of two Years next after my decease and not before Also I give to my two Kinsmen Henry Spratt of New Sarum and Richard ffittsall of ffisherton Anger One Guinea a piece Also I forgive and remit to Peter Paine of Longbridge Deverill a Blind man all and whatever Debt and Debts he shall owe or stand indebted to me at the time of my decease on any amount whatsoever Also I give devise and bequeath all the rest residue and remainder of my moneys Goods Chattels and Effects and all other my Personal Estate whatsoever and wheresoever to my Kinsman John Painter the Younger son of my said Brother in Law John Painter and I make nominate and appoint him my said Brother in Law John Painter my sole and only Executor And I further nominate and appoint George Wansee Overseer and Trustee of this my said Will desiring him to see the same to be duly Performed and to direct and assist my said Executor in the Execution thereof In Witness whereof I have hereunto set my hand and Seal the twentieth day of March in the Year of our Lord 1746 the mark of Martha Millard
