In the Name of God Amen I Henry Sainsbury Senior of Littleton Pannell in the Parish of Lavington Episcopi in the County of Wilts Yeoman being weak of Body but of Sound & Perfect Mind & Memory Praise be therefore given to Almighty God for it do make & Ordain this my last Will & Testament in Manner and Form following (that is to say) first & Principally I commit my Soul into the Hands of Almighty God whenever he shall please to call me hence trusting through the Merits Death & Passion of my Saviour & Redeemer Jesus Christ to have a full & free pardon of all my sins & to inherit everlasting Life And my Body I commit to the Earth to be decently buried at the Discretion of my Executor hereinafter named & as touching my Worldly Goods which God hath been pleased to give me I give & dispose of as follows Imprimus I give & bequeath unto my son James Sainsbury the sum of One Shilling Item I give and bequeath unto my Daughter Ann Sainsbury One Shilling Item I give and bequeath unto my Son Henry Sainsbury One Shilling Last of all I do hereby make my Dear Wife my Sole Executor of all that I have for so long time as she shall remain Sole & Unmarried

In Witness whereof I have hereunto set my Hand & Seal the Fifteenth day of April 1744 Henry Sainsbury's mark and seal

This will was proved at Market Lavington June 20th 1746 before the Revd Saml Rolleston Master of Arts Lawfull Surrogate of the Revd Worshipfull Henry Stebbing Dr in Divinity Chancellor of the Diocese of Sarum and by him advised of the effects of the said Testator was granted to Margt Sainsbury the Executrix within named being first sworn to the truth of the said will to perform and to Execute a just and true account when Lawfully required
