## Winterslow Aprill 7 1650

In the Name of God Amen I Jo: Thistlethwaite of East Winterslow in the County of Wilts being weake in body but of perfect understanding thankes be to God doe make and ordaine this my last Will and Testament in manner and forme following (that is to say) ffirst I comitt my Soule into the hands of God and my body to be buried in Xtian buriall at the discretion of my Executrix herein mentioned and as for my worldly goods and Estate God hath blessed me withall I thus bestow it Imprimis Whereas I have formerly given my Couz: Jo: Thistlethwaite of Horseshoe Hill a bond upon his Marriage to pay

him 200L my Will is that debt should be made good and paid unto him or to his Executors and the accompt of what he has received of the same money be brought unto my Executrix and what remained due of it unpaid by my Executrix It: I give unto Eliz: Holloway and Will: Holloway the 2 Children of Jo: Holloway of Broughton in Hampsheire the sume of twenty pounds apeece to be paid in six moneths after my death and in case either of them faile or dye the whole fourty pounds I give and bequeath to the Survivor of them It: I give to Martha Sherrier forty shillings Lastly all the rest of my goods and Chattells bonds and Debts and funerall Expences I give and bequeath unto Mary Holloway the wife of Jo: Holloway of Broughton aforesaid whome I make full and sole Executrix of this my last Will and Testament hereby revoaking all former Wills and I doe here nominate my Couz: Jo: Thistlethwaite of Horseshoe Hill aforesaid my Overseer in trust to aid and assist my Executrix and to see that this my Will be duely and faithfully performed .... that they will loveingly agree in the due execution thereof And this I doe declare to be my last Will and Testament and in Wittnesse hereof I have sett my hand and Seale the day and yeare above said the marke of Jo: Thistlethwaite signed sealed and declared in the presence of Gab: Thystlethwayte\_ John Tegge\_ the marke of Dorothy Ingram 14 February 1658/9 Administration with Will annexed to John Thistlethwaite the Nephew PCC Prob11/386 ©Wiltshire OPC Project/2015/Ros Dunning
