In the name of god Amen the xxii Daye of November in the yere of our lord God a thousand five hundred seventie fower I John Saulter of Marston in the parrishe of Pottarn in the Countie of Wiltes husbandman being sick of bodie but of good and perfitt remembrance thanks be to god Doe make this my Last will and testament in manner and forme following ffirst I bequeath my soule to Almightye god my bodie to the earth from whence it came Item I give unto Ladie Churche of Sarum xiid Item I give and bequeth unto the Churche of Pottarn vid Item I give and bequeath unto John Saulter my sonne Twenty pounce of good and lawfull money of England to be paid unto him when he shall come to the age of Twentie yeeres Item I

give and bequeath unto the same John my Lease and yeres that is to come of my house in wotton Item I give and bequeath to my Sone Richard vi xiii iiiid to be paid to him when he shall come to the age of Twentie yeres and twoe ewes and the house and Backside that Briant dwelleth in to be Delivered when god doth call me awaie and so to have the proffitt of the same house so long As my sone Thomas Doe live I give and bequeath to my Daughter Maude xiiil vis viiid and the best bedd savinge one and a pair of blanketts one coverledd and one bolster to be paid at the Daie of hir marriage Item I give and bequeath to my Daughter Jone xl to be paid at the Daie of hir mariage Item I give and bequeath to my Daughter Elizabeth vil xiiis iiiid to be paid at the Daie of hir marriage Item I give and bequeath to my Daughter Alice vil xiiis iiiid to be paid at the Daie of hir marriage Item I give and bequeath to my Daughter Edie thelder vil xiiis iiiid to be paid at the Daie of hir marriage Item I give and bequeath to my Daughter Die the yonger Six pounds thirteen shillings fower pence vil xiiis iiiid to be paid at the Daie of hir marriage The residue of all my Goods moveable and unmoveable (my legacies performed and my Debts paid) I give and bequeath to Jone my wief and Thoms my Sone whome I doe make my Whole executors upon condition that Thoms my aforesaid Sone will suffer his mother quietlie to enioye the one half of the tenement or bargain that I nowe Dwell in withall the appurtenances therunto belonging so longe as she Doth kepe her Self Widowe bearing like Charge and receyving ...all profite otherwise the said Thoms to be no executor but Jone my wief to be my whole executor except he wilbe agreable that his mother shall enioye the one halfe of the bargain according to my will and testament whereby shee maie be better able to bring upp hir children And I Doe also make my brother Thoms Saulter my overseer in whome my trust is to see all things performed accordinge to this my present Testament and last will Witness hereunto Thoms Saulter Richard Bryant and John Saulter the yonger
