In the name of God Amen, I **Stephen Gaysford** of Marston in the p[ar]ish of Potterne in the County of Wilts gent being in i[m]p[er]fect health of body and of sound mynde and disposing memory prayse be given to god therefore, but being sensible of the frailty and uncertainty of this life doe make & ordaine this my last Will & Testament following ©Wiltshire OPC Project/Colin Moretti/2012

Revoking disannulling and making voyd all former and other Wills by me made whatsoever And first I bequeathe my soule into the hands of Almighty God that gave it me, trusting in & through the merritts of his sonne Jesus Christ my blessed Saviour & deare Redeemer to Inherite eternall and salvaton and my body I commit to the earth from whence it was taken, to be buryed at the discretion of my Executor hereafter named, And as for touching and concerning that temporall estate the Lord of his mercy hath been pleased to bestow upon me I dispose thereof as followeth Imprimis I give and bequeathe unto the poor of the Tything of Marston the sume of Tenn shillings to be disposed amongst them according to the discretion of my Executor hereafter named Item I give unto my sonne Stephen Gaysford the sume of Five Pounds of Lawfull money of England to be payd halfe a yeare after my decease Item: I give unto my sonne John Gaysford All that my freehold land of Inheritance situate lying & being in Marston aforesaid which was formerly purchased of one Christopher Merewether by my father in Law Roger Long and now in my possession to hold to him the said **John** and his Heires for ever; Item I give unto my said sonne John All my household goods and implements of household situate & being in my house in Marston (Except two of my best feather beds, bedsteads and all the furniture thereunto belonging which I do hereby give unto my two daughters Elizabeth Crowch and Anne Gaysford to be equally divided between them, Item: I give unto my said daughter Anne the sume of One Thousand Pounds of Lawful money of England to be payd unto her when she shall attaine the age of One and Twenty yeares; And if she shall happen to dye before she attain that age; then and in such case my will is that the said sume of One Thousand Pounds shall be equally divided between my said daughter

Crowch & my sonne **John** ^ Item: I give unto my sonne in law **Richard Crowch** gent All that my freehold Land of Inheritance situate lying & being in Marston, which was ©Wiltshire OPC Project/Colin Moretti/2012

for ever Upon condition neverthelesse that he the said Richard Crowch shall pay out of the said Land unto my said daughter **Anne Gaysford** the yearly summe of Twenty Pounds of Lawfull money of England the same to be payd halfe yearly by even and equal portions until she shall attayne the age of One & Twenty Yeares; Item all the rest residue & remainder of my goods & chattells moveable & unmoveable[?] whatsoever I give & bequeath unto my said sonne in law **Richard Crowch** whome I do hereby nominate & appoint my whole & sole Executor of this my last Will & Testament; In witnesse whereof I have herunto sett my hand & seale the three & Twentyth day of December in the second yeare of the Raigne of [?] Sovraigne Lord James the second over England King &c Anno Dno 1686
