

Will of Henry Mead of Wyllye

Proved 1836



This is the last Will and Testament of me Henry Mead late of Bathwick near the City of Bath but now of Wily near Warminster in the County of Wilts Yeoman in the first place I direct all my just debts funeral and testamentary charges and expences to be paid and satisfied by my executor hereinafter named I give and devise all that my lifehold Estate and premises with the appurts situate at Wyly aforesaid now in my own occupation unto my nephew Henry Mead his heirs executors admors and assigns for all my estate and interest therein I give and bequeath the following legacies to the several persons hereinafter named that is to say to Sarah Bryan daughter of Thomas Bryan late Parish clerk of Chelsea in the County of Middlesex and niece of my late wife Ann Mead (formerly Ann Cobbett spinster) the sum of one hundred pounds To her brother George Bryan the sum of Seventy Pounds to James Cobbett brother of my said late wife the sum of Seventy Pounds to George Cobbett nephew of my said late wife the sum of thirty pounds to ffanny Mead widow of my brother the late James Mead the sum of fifty pounds To William Mead and Susan Dawkins the wife of Dawkins of Hants Children of my late brother James Mead each the sum of fifty pounds and to my nephews and nieces Ann Mead Thomas New Mead Sarah Mead Martha Mead Mary Mead Harriott Mead Henry Mead and Sophia Mead children of my said late brother John Mead each the sum of fifty pounds and I direct all the said several legacies to be paid within six months after my decease and as to all the rest residue and remainder of my personal estate and effects whatsoever and wheresoever or of what nature or kind soever (subject to the payment of my debts funeral and testamentary charges and expences and the legacies hereinbefore given by me) I give and bequeath the same to my nephew William Mead his executors admors and assigns to and for his and their own absolute use and benefit and I nominate constitute and appoint my said nephew William Mead sole Executor of this my Will and hereby revoke all former wills and codicils by me at any time heretofore made In Witness whereof I the said Henry Mead the Testator have to this my last will and testament set my hand and affixed my seal the ninth day of April one thousand eight hundred and thirty Henry Mead

This is a Codicil to the last will and testament of me Henry Mead of Wylly in the County of Wilts Yeoman Whereas I have in and by my said will given and bequeathed Part of my Property to or in favor of Sarah Bryant of Chelsea in the County of Middlesex a niece of my late wife And whereas the said Sarah Bryant has since married now I hereby will and direct that all and whatsoever I have by my said will given and bequeathed to or in favor of the said Sarah Bryant shall be paid made over and assigned to her separately and apart from and independently of her present or any future husband and that her sole receipt or receipts shall be the only sufficient discharge or discharges for the same In Witness whereof I have hereunto set my hand and seal the fourteenth day of September one thousand eight hundred and thirty three Henry Mead
