We declare that the total of the above rate amounts to the sum of one hundred and seventy eight pounds, one shilling and four pence half penny. We the undersigned who hereby declare that one of us, or some person on our behalf, has examined and compared the several particulars in the respective columns of the above Rate with the Valuation List made under the Authority of the Union Assessment Committee Act if 1862 in force in this Parish, and several hereditaments are to the best of our belief, rated according to the value appearing in such Valuation List.
